

# **Our Results**

#### Type of Deal: Mixed Portfolio Purchase

#### What we did

BBIG sourced and partnered with the purchase of 35 units across Ayrshire and Fife. Through our sister companies MWD Residential Lettings and Brighton & Beck, we successfully secured, controlled tenant handovers and evictions, managed all required refurbishment and sold all units through our auction and estate agency (Brighton & Beck). This achieved completion of all stock within 6 months.

#### Type of Deal: JV on assisted sale

#### What we did

Through our dedicated lead generation we sourced this threebedroomed semi-detached in Aberdeen. The deal only required a cash advance of £20,000 with an AS agreement in place with the vendor. Due to the As agreement, we are able to sell the property immediately, avoiding the 6-month rule. End profit £20,000.

#### Type of Deal: JV buy to let

#### What we did

A full three-bedroomed HMO in the heart of Aberdeen. Purchase £70,000, Refurbishment £10,000, Refinance £125,000. Rented at £900pcm (£10,800pa NET) and £9,504 Gross. Yield 10%



### Our Results (Continued)

#### Type of Deal: JV commercial to residential development

#### What we did

Secured by BBIG for an off-market JV investor. Development of a former solicitors office to form two modern flats. BBIG have dealt with Purchase, change of use, architects, achieving planning, warrants and required engineers reports and all the way through build material costs, trade quotations, PM and will control both sales through our Team at Brighton & Beck using CGI rendering to achieve both sales prior to completion of works.

#### Type of Deal: Direct to Vendor Portfolio of 12 tenanted flats

#### What we did

Valued at £1,150,000, Purchase £860,000, Discount 25%, Rental Yield Net 11%. Fully let and managed by our lettings team at MWD Residential Lettings.

#### Type of Deal: A sourced deal of 4 units through our letting agency

#### What we did

Valued at £480,000, Purchase £357,000, Discount 36%, Rental Yield Net 9%. Fully let and managed by our lettings team at MWD Residential Lettings
